

## **Fallout® 4 Xbox® One Wasteland Workshop Sweeps**

### **OFFICIAL SCAVENGER HUNT AND SWEEPSTAKES RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. **Fallout® 4 Xbox One Wasteland Workshop Sweeps** (the “Wasteland Workshop Sweeps”) is sponsored by Bethesda Softworks LLC (the “Sponsor”). For the purposes of the Sweepstakes, the “Sweepstakes Group” is composed of the Sponsor, together with its affiliates and related companies, including without limitation its parent, sister and subsidiary companies, retailers, franchisees, advertising and promotion agencies, suppliers of material and services related to the Sweepstakes, and any other corporation, partnership, sole proprietorship or other legal entity directly involved in the Sweepstakes and their respective officers, directors, employees, agents, and other representatives.

#### **1. SWEEPSTAKES PERIOD**

The Sweepstakes starts on **Tuesday, April 12, 2016 at 1 p.m. EST** during the Bethesda Softworks Twitch stream on [Twitch.tv/bethesda](http://Twitch.tv/bethesda) and ends approximately an hour later at the conclusion of the broadcast (the “Sweepstakes Period”).

#### **2. ELIGIBILITY**

All participants must be 18 years of age or older at the time of entry, must possess a valid form of identification and be a legal resident of one of the (i) 50 United States (or the District of Columbia) excluding the territories, military installations and commonwealths, (ii) United Kingdom (iii) Spain (iv) France (v) Germany (vi) Austria (vii) Italy (viii) Poland (ix) the Netherlands (x) Denmark (xi) Finland (xii) Luxembourg (xiii) Norway (xiv) Russia (xv) Australia and (xv) New Zealand. All applicable federal, national, state, provincial and local laws and regulations apply. Void where prohibited, restricted or taxed by law. Excluded from eligibility are officers, directors, employees, agents and representatives of Sponsor, each of its respective parent, affiliated or related companies, agencies, suppliers of the materials and services related to this Sweepstakes, and members of any immediate families (defined as parents, siblings, children and spouses, regardless of where they live) or households (whether or not related) of such officers, directors, employees, agents and sales representatives.

**3. HOW TO ENTER AND WIN THE WASTELAND WORKSHIOP SWEEPS NO PURCHASE NECESSARY.** Internet access and a valid Twitch account necessary.

At approximately 1 p.m. ET during the Twitch stream, the Sponsor will formally kick off the Sweepstakes Period and let viewers know the keyword to use. To enter the sweepstakes, entrants must (i) enter the Twitch chat stream during the time of the drawing (ii) follow the Bethesda channel at [Twitch.tv/Bethesda](http://Twitch.tv/Bethesda) and (iii) type in the keyword !WastelandWorkshopSweeps on the Twitch channel chat mode .

At the conclusion of the broadcast , the Sponsor will select and announce the winner subject to confirmation of eligibility requirements and reach out directly to them using Twitch.TV’s private messaging.

Once your submission is received, you will receive one (1) entry (each an “Entry” or collectively, the “Entries”) into the Sweepstakes. By submission of an Entry, you confirm that you have read, understood and agree to abide by these Wasteland Workshop Sweeps rules. You must satisfy the eligibility requirements listed in Section 2 above or your submission will be void and ineligible for entry into the Sweepstakes. You represent and warrant that your submission is not libelous, defamatory, profane or obscene and does not infringe upon the intellectual property rights, rights or privacy or personality or any other statutory or common law rights of any other person. Limit: One (1) Entry per person during the Sweepstakes Period. Entry must be submitted by the entrant him or herself. The Wasteland Workshop Sweeps Winner will be notified at the conclusion of the Bethesda Twitch Stream and Sponsor will mail the prize to the mailing address provided by the winner. The Wasteland Workshop Sweeps winner may also be required to complete and return to Sponsor (or its authorized agent) by the deadline specified in the documents a written affidavit of eligibility (or declaration and release) and publicity release form (collectively, the “Release”), releasing the Sweepstakes Group from any liability in connection with this Sweepstakes or the acceptance, possession, use or misuse of any prize.
